Discuss/Approve Building Permits: Schwanz made the motion to approve the building permit for Kevin Bieret upon Jim Herrig's approval, Riedell seconded. Ayes: All. Motion carried.

Discuss/Approve TIF Projects: 14,400-20,000-11,260: The \$14,400 was for the parking lot for trucks at the airport. The \$20,000 is our half of the blacktop project over by CPS south of town. The \$11,600 is for the seal coating done on 1^{st} street.

Discuss/Approve Mutual Aid Agreement: This agreement allows us to provide or receive aid in a disaster situation from surrounding communities and out of state. Schwanz made the motion to approve the Mutual Aid Agreement. Germann seconded. Ayes: All. Motion carried.

Randy Nuetzman asked council if the empty lot across from Albrecht's could be used as a tractor and machinery display during Farm Festival.
