The Clerk will contact engineer and see if he can get drawing of proposed project by the airport hangar for the council to get a clearer picture of the plan.

Discuss/Approve Buy back the Music building: Steinkamp suggested buying back the music room from the WLCIC to utilize for REC center projects. Mott made the motion to approve an offer of \$20,000.00 to the WLCIC to buy back the music room. Nuetzman seconded. Ayes: All. Motion carried.
